

2000/2001 COMBINED FEDERAL CAMPAIGN CALENDAR OF EVENTS

September 1 - December 15, 2000	Combined Federal Campaign Official Solicitation Period.
December 1, 2000	OPM will begin to accept National Applications.
January 31, 2001	Closing Date for National Applications (<i>Must be received in CFC Office no later than 5:00pm est.</i>)
January 22, 2001	Deadline for LFCC to advertise for PCFO Applications via Public Notice. Must remain open 14 calendar days.
February 23, 2001	Recommended Deadline for PCFO Applications to the LFCC.
March 4 – 7, 2001	OPM Regional Workshop in Jacksonville, FL.
March 11-14, 2001	OPM Regional Workshop in San Francisco, CA. <i>Registration packets will be mailed during January 2001.</i>
March 15, 2001	Deadline for Submission of Campaign Results to organization and Form 1417 to OPM. (The deadline of February 15 noted in the regulations has been waived; however, NO ADDITIONAL EXTENSIONS WILL BE GRANTED AND SANCTIONS WILL BE ISSUED TO ANY PCFO MISSING THE DEADLINE.) Numbers given at this time will be final..... no corrections or updates will be permitted. Target date for PCFO to mail all Donor Acknowledgement names to Federations and Agencies.
March 15, 2001	Recommended Opening Date for Local Application (Recommended date only -- LFCC's may determine the application period dates for their individual campaign -- <i>however all local application decisions must be completed by the LFCC no later than May 5, 2001.</i>)
March 16, 2001	Deadline for LFCC to Select PCFO.
March 16, 2001	Target Date for Eligibility Notices to National Applicants from OPM.
April 1-4, 2001	OPM Regional Workshop in Chicago, IL. <i>Registration packets will be mailed during January, 2001.</i>
April 2, 2001	Deadline for CFC's >\$500,000 to Begin Monthly Disbursements.
April 16, 2001	Recommended Closing Date for Local Applications -- <i>all local eligibility decisions must be completed by the LFCC no later than May 5, 2001.</i>
May 7, 2001	Deadline for all local eligibility decisions to be made by LFCC.
May 11, 2001	Recommended Date for LFCC to Notify Eligibility Decisions in Writing.
May 25, 2001	LFCC's begin receiving appeals within seven (7) business days of the date of receipt of the initial LFCC decision or fourteen (14) calendar days from the date the decision was mailed, whichever is earlier. It is strongly recommended that all appeals be considered within 10 calendar days or by June 8, 2001.
May 21 – 25, 2001	Receive Last Batch of Appeals from National Organizations.
June 1, 2001	Deadline for CFC's < \$500,000 to Begin Quarterly Disbursements.
June 8, 2001	Deadline for decisions by LFCC on all local organization appeals.
June 25, 2001	Organizations may appeal adverse local eligibility determinations by the LFCC. The Office of Personnel Management must receive these within ten (10) business days of the date of receipt of the letter from the LFCC denying eligibility on appeal.
July 15, 2001	Target Date for 2000 National List forwarded to Local Campaigns on Diskette.
July 30, 2001	Target date for the Office of Personnel Management to complete Local Appeals and notify LFCC's and Local Agencies.

December 3, 2001

OPM will begin to accept national application for the 2002 campaign.
